Personally I have riparian fishing rights at Linloskin – the lower limit of these fishings are at the weir directly above the Suspension Bridge. This is just above the upper limit of the FPS. However, the works required for the FPS are likely to impact my fishings as any discloured water, noise or vibration in the river will discourage the upstream movement of salmon and seatrout – thereby affecting my fishings.

The Cree DSFB do not own any fishings. However, they are the elected body legally responsible for the protection and enhancement of Salmon and seatrout within the entire River Cree catchment. I strongly suggest you familiarise yourselves with the legal powers which the Cree DSFB have.

The town depends on tourism, I also have concerns for the salmon, which as you may know are in real trouble as a species, we have a hatchery on the river which we all try to help fund in various ways and have done for years, if there are no fishermen there will be very little support for the hatchery and I fear for its survival, Newton Stewart I feel as a town in disrepair to start with , the last thing we need is ugly walls being built all over the prime beauty spot, I have fished the river Cree in the town for more than 30 yrs, the main reason for moving here is the fishing and I'm not the only one who chose to retire here for said reason, I know the concern about flooding in Newton Stewart as far as I can remember the river as only flooded twice in the 30 yrs I've been fishing. one of the times I saw it flood the town the reason being a badly maintained wall collapsed behind Homehardware shop but for that town would have been fine. The problem with the river for me is the amount of the catchment area that is being drained to fast by the forestry up stream so they can plant trees, and to prove that go back 30yrs after a spell of heavy rain the river would run off a lot slower than it does now the catchment acts like a sponge and would release excess water slowly the rivers would cope and stay high for a week, it was perfect for us fishermen and the salmon! Now the river rises very quickly and falls within 24 hours and that is the reason for flooding, I believe the cost of this eyesore your building is not practicable and will cause problems further down river creating more flooding, the money could be better spent in Newton Stewart on a much needed Hospital and the flooding fear should be tackled at source in the catchment area (that's what other councils are pursuing)

Hello, we have just returned from holiday and have now read your email regarding our fishing rights.

Our title deeds, which are held with our solicitor, show that we own approximately 90 metres of the riverbank.

The river, being non-tidal at this point, and separating our property from that of the adjoining landowners property, the legal presumption is that both parties shall own up to the mid point of the river known as the 'medium filum'. Therefore fishing rights for all indigenous river fish (ie. brown trout but not sea trout and salmon) belong to us as the riverbank owners.

I hope this clarifies our position.
